# Volunteer Minor Release

This is a legally-binding release to GiftsToGive, Inc., a Massachusetts nonprofit corporation and tax-exempt public charity ("GiftsToGive").

I have volunteered to assist GiftsToGive with its charitable activities. I have volunteered my time and services because I support GiftsToGive and desire to participate actively in furthering its charitable purpose. I understand that my activities as a volunteer may entail a risk of physical injury and I may be exposed to hazards, including the hazards associated with manual labor and operating a motor vehicle. I understand and assume all such risks. Because the assertion of claims against GiftsToGive for personal injury occurring during my volunteer service would be antithetical to my support of GiftsToGive and its goals and would reduce the ability of GiftsToGive to accomplish its charitable purpose, and in consideration of GiftsToGive permitting me to engage in volunteer activities and other good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge, I am granting this Release. I agree to abide by all rules and regulations of GiftsToGive regarding safety and use of any and all equipment. I understand that no drugs or alcoholic beverages are to be consumed by volunteers during volunteer activities and that I will be asked to leave the premises or, if off the premises, to immediately cease my volunteer activities, if suspected to be under the influence of same.

On behalf of myself, my estate and the personal representative thereof, my heirs and assigns, I hereby forever release and discharge GiftsToGive, its officers, directors, employees, volunteers and agents, from any and all actions, causes of action, suits, demands, costs, claims, losses, liabilities and damages arising at any time out of, or in any way related to, my service as a volunteer for GiftsToGive (including, but without limiting the generality of the foregoing, any claims or liabilities arising directly or indirectly out of any accident, incident, or occurrence in connection with my volunteer activities). I intend this Release to be effective, regardless of whether the claim of liability is asserted in negligence (including without limitation gross negligence), strict liability in tort, other theory of tort recovery, or on any other basis. For myself, my estate and the personal representative thereof, my heirs and assigns, I covenant and agree to make no claim, nor to institute any suit, action or proceeding against GiftsToGive, its officers, directors, employees, volunteers or agents, arising at any time out of, or in any way related to, my service as a volunteer for GiftsToGive (including, but without limiting the generality of the foregoing, any claims or proceedings arising directly or indirectly out of any accident, incident, or occurrence in connection with my volunteer activities).
