We have reviewed the accompanying financial statements of Gifts to Give, Inc. (a non-profit organization), which comprise the statement of financial position as of March 31, 2023, and the related statements of activities, functional expenses, and cash flows for the year then ended, and the related notes to the financial statements. A review includes primarily applying analytical procedures to management's financial data and making inquiries of management. A review is substantially less in scope than an audit, the objective of which is the expression of an opinion regarding the financial statements as a whole. Accordingly, we do not express such an opinion.

### 1. Organization

Gifts to Give, Inc. (the "Organization") was organized under the laws of the Commonwealth of Massachusetts for the purpose of operating a large-scale repurposing center, designed to use thousands of student volunteers to reprocess donated in-kind items designated for children residing on the south coast of Massachusetts.

### 2. Summary of Significant Accounting Policies

#### *Basis of Presentation*

The accompanying financial statements of the Organization are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

The statement of financial position presents two classes of net assets (net assets without restrictions and net assets with restrictions) and the statement of activities displays the change in each class of net assets.

The classes of net assets applicable to the Organization are presented as follows:

*Net Assets Without Restrictions* - Net assets that are not subject to donor-imposed restrictions.

*Net Assets with Restrictions* - Net assets that are subject to donor-imposed stipulations that may or will be met, either by actions of the Organization and /or passage of time.

#### *Use of Estimates*

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### *Donated Items*

The Organization receives donations of new and used supplies and equipment from individuals and organizations in the United States. The Organization in turn, gives these donated goods, at no charge, to other organizations with the intent of the goods ultimately being delivered to children in need. The Organization records the donated goods at their estimated fair value on the date of donation. During the years ended March 31, 2023, the Organization received donations of supplies with an estimated fair value of \$122,130.

To determine fair value, the Organization gathers as much information as possible on each donated good. The value is obtained by researching websites of vendors selling similar goods. If the value for the exact piece cannot be obtained, then the value for a comparable item can be substituted.

### 2. Summary of Significant Accounting Policies (cont.)

#### *Donated Services*

Donated services are recognized as contributions if the services a) create or enhance nonfinancial assets or b) require specialized skills, are performed by people with those skills, and would otherwise be purchased by the Organization. Volunteers also provided services throughout the year that are not recognized as contributions in the financial statements since the recognition criteria were not met.

#### *Recognition of Donor Restrictions*

Net assets that are subject to donor-imposed stipulations that may or will be met, either by actions of the Organization and /or passage of time. When a restriction expires net assets with restrictions are reclassified to net assets without restrictions and reported in the statement of activities as net assets released from restrictions. Restricted gifts whose purpose restriction is met in same year the gift is received is reported as unrestricted support.

#### *Property and Equipment*

All acquisitions of property and equipment in excess of \$1,500 and all expenditures for repairs, maintenance, renewals, and betterments that materially prolong the useful lives of assets are capitalized. Property and equipment are carried at cost or, if donated, at the approximate fair value at the date of donation. Depreciation is computed using primarily the straight-line method over the estimated useful lives of the assets. Estimated useful lives are five years for office equipment and ten years for furniture and fixtures. Leasehold improvements are amortized over shorter of their estimated useful life or the terms of the related leases.

#### *Advertising*

The Organization expenses advertising costs as incurred. Advertising expense amounted to \$14,215 for the year ended March 31, 2023.

#### *Functional Expense Allocation*

The costs of providing various programs and other activities have been summarized on a functional basis in the statement of functional expenses. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

### 2. Summary of Significant Accounting Policies (cont.)

#### *Income Taxes*

The Organization is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. The Organization is also exempt from Massachusetts state income taxes under Massachusetts General Law 180. However, income from certain activities not directly related to the Organization's tax-exempt purpose is subject to taxation as unrelated business income at both the federal and state levels. In addition, the Organization qualifies for the charitable contribution deduction under Section 170(b)(1)(A)(vi) and has been classified as an organization other than a private foundation under Section 509(a)(1).

The Organization evaluates all significant tax positions. As of March 31, 2023, the Organization does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Organization's tax returns are subject to examination by the appropriate taxing jurisdictions. As of March 31, 2023, the Organization's federal and state tax returns generally remain open for examination for three years from the date filed with each taxing jurisdiction.

#### *Management Review*

The Organization has evaluated all subsequent events through April 5, 2024, the date the financial statements were available to be issued.

### 5. Leases

The Company entered into a lease agreement for warehouse and office space located at One Titleist Drive, Acushnet, Massachusetts under a non-cancelable operating lease commencing August 1<sup>st</sup>, 2014 and ending July 31<sup>st</sup>, 2017 with an option for two additional three-year periods. The Organization exercised the extension options and continued the lease to 2023. The verbal lease agreement expires on July 31, 2023 with a monthly payment amounting to \$4,875.

In connection with the lease, for the years ended March 31, 2023 rent expense was \$58,500. Under current professional standards, capitalization is not required as the remaining term is less than one year.

### 6. Concentrations

The Company has a potential concentration of credit risk in that it maintains deposits with a financial institution in excess of amounts insured by the Federal Deposit Insurance Corporation ("FDIC"). Beginning on January 1, 2013, the FDIC insures up to \$250,000, per depositor, per insured depository institution for each account ownership category. At March 31, 2023, there were no uninsured deposits.

*Grants, Individual Business Contributions, In-Kind:* The organization receives grants and contributions from outside organizations to assist the organization to better their community. It is recognized at a point in time, on the day the grant or contribution was given.

*Fundraising Income, Contributions non-cash, Yard Sale/ Rag Man, Book Buyer, eBay Sales, and Thrift Store:* The organization receives donating items from individuals and resells those items to donated the proceeds to the community. Revenue is recognized at a point in time, on the day the items are received and resell.

### 9. Prior Period Adjustment

During the review of the trial balance, it was noted that there were prior year tax related adjustments. Since the transactions were from the prior year, they are recorded as a prior period adjustment on the financial statements.
