We partner with over 200 community agencies that work directly with homeless and in-need children. These agencies order from us age and gender specific gift packages for the children in their care.

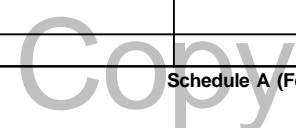

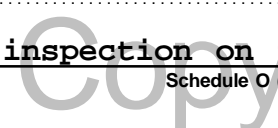
